


## Compton TOD Specific Plan Area

- The Plan Area includes 575.5 acres located in the north-central portion of the City of Compton
- The Proposed Project is the preparation of a Specific Plan to guide future growth in the vicinity of the Metro A (Blue) Line Compton Station.
- Focus growth in three downtown districts:
  - Civic Center
  - Commercial Core
  - Historic Core

- Enacted by the State Legislature in 1970
- □ Governed by:
  - The CEQA Statute
    - Public Resources Code Section 21000
  - The CEQA Guidelines
    - California Code of Regulations, Title 14, Section 15000
  - The Court

## Purpose of CEQA

- Identify potentially significant environmental effects.
- Prevent avoidable damage through mitigation measures or project alternatives.
- Provide public opportunity to comment.
- Disclose reason for approval even with significant effects.




## **CEQA** Applies

CEQA analysis occurs when:

- An activity directly undertaken by a government agency
- An activity financed in whole or part by a government agency
- A private activity which requires approval from a government agency

# NOP Scoping Discussion

The purpose of the NOP is to assist the City of Compton in determining the scope and content of the environmental information to be included in the EIR.

- What environmental issues should be analyzed in the EIR (i.e., known local issues or concern);
- What alternatives to the project should be evaluated (i.e., no project, different project); and
- What mitigation measures should be considered to help avoid or minimize significant impacts?



## NOP Public Review Period

In accordance with CEQA Guidelines Section 15082, this NOP is being circulated for a 30day comment period:

#### Friday, September 24, 2021, through Monday October 25, 2021

The City of Compton requests that written comments be provided at the earliest possible date, but no later than October 25, 2021.

REMINDER: Comments should be focused on the scope and content of the environmental information to be included in the EIR.
